2019 Indy Chamber Membership Program

- Members of the Indy Chamber may apply to become members of the Columbia Club through a special introductory promotional program. Provided below are the eligible membership classifications:
 - “Chamber” Resident Member: \$400 Initiation Fee (vs. \$500) / \$210 Monthly Dues (vs. \$265)** Members over the age of 37 whose principal residence or place of work is in Marion, Boone, Hamilton, Hancock, Shelby, Johnson, Morgan or Hendricks counties in Indiana. *(Overall annual savings: \$760)*
 - “Chamber” Associate Resident Member: \$240 Initiation Fee (vs. \$300) / \$155 Monthly Dues (vs. \$210)** Members between the ages of 30 and 36 years of age whose principal residence or place of work is in Marion, Boone, Hamilton, Hancock, Shelby, Johnson, Morgan or Hendricks counties in Indiana. *(Overall annual savings: \$720)*
 - “Chamber” Non Resident Member: \$240 Initiation Fee (vs. \$300) / \$130 Monthly Dues (vs. \$165)** Members whose principal residence and place of work is not in Marion, Boone, Hamilton, Hancock, Shelby, Johnson, Morgan or Hendricks counties in Indiana. *(Overall annual savings: \$480)*
 - “Chamber” Associate Member: \$100 Initiation Fee (vs. \$125) / \$110 Monthly Dues (vs. \$130)** Members who are between the ages of 21 and 29. *(Overall annual savings: \$260)*
- The monthly dues reduction will be valid for 12 months from date of application. At the conclusion of the 12 month membership, **dues will convert to the applicable rates in place at time of conversion.**
- Membership includes the **member and his or her spouse or significant other as well as dependent children through the age of 25.**
- All memberships will be held in the name of the member applying for membership (not the Indy Chamber) and will be billed individually.
- The Indy Chamber assumes **no liability for payment** nor does it guarantee membership approval in the Columbia Club.
- Monthly Dues are eligible for increase and Indy Chamber members will be subject to any applicable increases as announced to all club members (typically effective in January of any calendar year).
- This program may be discontinued by either party (Columbia Club or Indy Chamber) with 30-day advance notice.
- This special promotion is applicable to NEW Columbia Club membership applicants. Current Columbians are not eligible for a reduction in monthly dues.
